The Chinese Chamber, in cooperation with the State of Hawaii Department of Business, Economic Development, and Tourism (DBEDT), is planning a ten-day mission to China in the latter part of May. The areas of focus are business investment projects, tourism, and environmental protection. Management training programs by DBEDT and the Chinese Chamber will also be offered.

Seminars will be held and mutual counterparts from China and Hawaii will be able to discuss specifics. Possible programs are presentations of tourist potential and environment, and tourism development cooperation in joint venture tourist theme parks, joint ventures in tourist souvenir production, and tourism promotion.

Cities scheduled for this mission are Guilin in Guangxi province and Kunming and Lijiang in Yunnan province. FROM THE NEWSSTAND

...

In the January 15 issue of *Business Week*, "Shining A Light on China's Dark Side" is a review of Jasper Becker's recently published book, *The Chinese*. Becker is the Beijing bureau chief for the *South China Morning Post*. "Made in China" is a twelve-page article on the Pearl River delta in the January issue of *Travel and Leisure*. And this week's *Business Week* (March 5 issue) has a commentary on the Bush budget, opining that the spending plans and tax cut don't add up. That same issue has an editorial, "The Estate Tax: Mend It, Don't End It." The editors point out that "[V]ery few Americans currently pay estate taxes... Of all Americans who died in 1998, only 46,000 of their estates paid any tax; 44,000 had estates of \$4 million or less, and 2,000 paid about half the total. Estate tax insurance policies were used by many small-business heirs to pay their share." It may be well for Chamber members concerned about the impact of the federal estate tax on their children inheriting their small-business to contact their insurance agent and check into "estate tax insurance policies."

According to news reports early in February, State Representative **Lei Ahu Isa**, chair of the Economic Development Committee, has proposed eliminating the general excise tax (GET) on food purchases made by people age 65 years or older. In addition, she proposed raising the GET from four to five percent for all purchases of “luxury” items such as cars and jewelry valued at \$20,000.00 or

more, and increasing the food tax credit for low-income people to \$100.00. People may be surprised to find that many popular sport utility vehicles (SUVs), such as the Jeep Grand Cherokee and the Nissan Pathfinder, which sell for more than \$20,000.00 are “luxury” vehicles like the Mercedes and Lexus SUVs, which sell closer to \$30,000.00.

On Saturday, February 24, Chamber President **Victor Lim** swore in the 2001 officers and directors of the Chang Wing Yong Tong. Chamber members include **Gerald Y. Y.
