## HIREC luncheon

## *Hurricane Season Preparations*

The annual hurricane season began on June 1 and runs through November 30. Emergency preparation or disaster kits are available from the American Red Cross’s store ([www.redcrossstore.org](http://www.redcrossstore.org)) or from the ARC’s Hawaii chapter ([www.hawaii-redcross.org](http://www.hawaii-redcross.org)), either online or downtown. However, the local kits seem to be limited to one-person packages, and the recommendations on how to build a disaster kit cannot be printed out. The recommendations do point out that you should stockpile a gallon of water per person per day (two quarts for drinking and two quarts for food preparation and sanitation). On that score, the Red Cross kits don’t have nearly enough water. In addition, the Hawaii chapter should update its information – its “disaster preparation information” links to a 2002 national ARC hurricane Web page. An alternative for disaster supplies is The Hurricane Store ([www.hurricane-store.com](http://www.hurricane-store.com)). Hawaiian Electric has a free 96-page *Handbook for Emergency Preparedness*, which may be available at City Mill as well as HECO offices on Ward and Richards Streets. And remember that the three-day guidelines for supplies are for time spent in a shelter. Prudent planning would consider stockpiling 7-10 days of food and water for each person since that’s the time needed to ship supplies from the West Coast.

## CHAMBER NEWS & ACTIVITIES

### FONG-LONG SCHOLARSHIPS

Act 112 was signed into law by Governor **Linda Lingle** on the occasion of the Chamber installation luncheon. Introduced with bipartisan support (the twenty-two sponsors included Representatives **Jerry Chang** and **Corinne Ching**), House bill 1529 honors Republican **Hiram Fong** and Democrat **Oren Long**. Act 112 establishes two endowment trusts and scholarship programs at the University of Hawaii and \$50,000.00 is appropriated to each trust. Each trust will fund two scholarships each year. The Long scholarship will be awarded to a male and female graduate of Hawaii public schools who are upperclassmen at a University of Hawaii campus and who submit the winning essay on the senator's contributions to Hawaii. The Fong scholarship adds requirements that the recipients must demonstrate a commitment to local community issues through volunteer work and participation in community organizations, and also demonstrate interest and knowledge of the history of immigration to Hawaii. The one-year stipend may be used for tuition and fees, the cost of texts and instructional materials, room and board at a UH dorm or apartment, or the difference between student need and the cost of school attendance. Act 112 becomes effective on July 1.



## Trans Fat-Free

Those who shop at their friendly neighborhood supermarket for food may have noticed that many packages are now labelled “zero trans fats.” (Note, however, that the FDA’s regulation allows “trans fat-free” labels on foods with up to 0.5 grams of trans fats per serving). Many fast food chains have eliminated trans fats or partially hydrogenated oils from their cooking or at least their deep fat frying. In Tiburon, California, eighteen restaurants voluntarily switched to rice bran oil in “Project Tiburon.” In an article in *U.S. News & World Report*, **Brian Wilson** of Sam’s Anchor Café answered the reporter’s questions. He indicated that rice bran oil is neutral (adding no flavor, unlike vegetable, grape seed or avocado oils), higher-quality (so that it doesn’t break down as rapidly as other oils do), and has a higher burning point (unlike olive oil) for deep fat frying. With that oil, it wasn’t necessary to raise prices and customers didn’t notice the change from trans fat oils. Wilson also pointed out that with frozen French fries, the processor may have already pre-cooked them in trans fat oils. Anyway, for some of our restaurant owner-members who may be looking for a trans fat-free oil, especially for deep fat frying, check the Web site for California Rice Oil Company at [www.californiariceoil.com](http://www.californiariceoil.com).

## Chamber Installation



For a change this year, the Chamber departed from a long tradition of installation banquets in the evening to a lunchtime event. So on Thursday, May 31, some 320 Chamber members and friends gathered at the Hibiscus Ballroom of the Ala Moana Hotel. Starting at 11:00 a.m., fourteen individuals and companies had display tables in the foyer. They took advantage of the opportunity to showcase their services to

those moving from the check-in table to the receiving line. The exhibitors included ABC Wireless, Best Mortgage, China Airlines, **Corinne Ching**, John Hancock, Pacific Resources LLC, Pacific Wealth Management LLC, Panda Express, Principal Financial Group, Sturdivant Publishing, Sui Wah School, Sunrise Group, and the U.S. Department of Labor, which had a number of brochures and other handouts for business owners.

The sit-down lunch featured Chinese chicken salad, seven kinds of *dim sum*, and long-life noodles. Dignitaries present included Governor **Linda Lingle**, Mayor **Mufi Hannemann**, TECO Director General **Philip Wang**, state Senate President **Colleen Hayabusa**, and state House speaker **Calvin Say**. Both state Representative Corinne Ching and Councilman **Rod Tam** brought resolutions. Governor Lingle gave a brief recap of recent pro-business legislation and used the occasion to sign House Bill 1529 (now Act 112), which established endowments and scholarships named after **Hiram L. Fong** and **Oren E. Long**, Hawaii’s first U.S. senators. A big *mahalo* to installation chair **Libby Lew** and her committee for a job well done.

On Thursday, May 23, the Chamber held its first International Chamber Challenge Golf Tournament at the Navy-Marine Golf Course.
