## AFTER TAXES FUN-RAISER

Federal and state tax returns are due on April 15 and April 20, respectively. ## “Passports. Passports, Please.”

For those of you contemplating going on the Narcissus Goodwill Tour, please remember that you must have a valid U.S. passport that will still have at least six months validity after the trip. If you have never had a U.S. passport or your passport was issued more than 15 years ago, you can get the necessary application (Form DS-11) online. If you have a U.S. passport issued less than 15 years ago, you can use Form DS-82, also available online. Currently, passports or renewals cost \$75.00 (plus \$25.00 “execution fee” for new passports), but some time later this year, the initial passport fee will go up to \$135.00 while the renewal fee will go up to \$110.00. Since a U.S. passport is valid for ten (10) years, it may be worthwhile to get one before the fees go up. (You never know when you may need one). You should be aware that at present, “routine service” takes 4-6 weeks while “expedited service” takes 2-3 weeks and costs an additional \$60.00. Also, while a visa is not needed to visit Hong Kong, a PRC visa is required to enter China and may take an additional two weeks since the passport must be mailed to the PRC consulate in Los Angeles. I also had a chance to scout several of the tourist attractions that we will visit in the seaside resort of Qinhuangdao, which should be very interesting to Chinese history buffs and to nature lovers. We may even take in a famous European villa or two if the time permits. **Bo Wu**, Executive Director of the State of Hawaii Office in Beijing, informed me that Governor **Linda Lingle** will join portions of our trip, including a 25th year celebration our sister-state relationship with Guangdong province; a visit to the Yunnan cities of Kunming and Lijiang, a UNESCO Heritage Site; and may even travel with us to Beijing. After Expo 2010 in Shanghai, much of our remaining time will be spent in the fabulous shopping cities of Shenzhen and Hong Kong before heading home.

*Mahalo* to Chinese Chamber member and co-chair **Robert Yu** for helping to coordinate the March 25 Congressional Forum jointly sponsored by the Honolulu Japanese Chamber of Commerce, the Hawaii Association of Realtors, and our organization. With such a critical election upon us for the recently vacated First Congressional District seat, it was important to hear the candidates' stand on the many issues confronting Hawaii and our nation.

On March 27, there was a very successful tax seminar taught by our members **Tina Au** (H&R Block), **Tom Yamachika** (Accuity LLP), and Dr. **Thomas Pearson** (Shidler College of Business), and also **Jonathan Hall** (ProService). The event was moderated by our member, **Michael Ching** (Ernst & Young), organized by Vice President of Business Development **Libby Lew**, and sponsored by the Hawaii Mainland Overseas Chinese Association as well as Chamber director, L&L founder **Eddie Flores, Jr.** Thank you to all the people and organizations involved. The attendees were given important tips for individual and business taxes, learned about the general excise tax, and received strategies for avoiding an IRS audit.

Both the Congressional forum and tax seminar would not have been possible without our partners. Partnerships will become increasingly more important as the Chinese Chamber expands its role to promote business and help the community under the Chinatown Community Development Center (CCDC).

One such expanding partnership is with the University of Hawaii's Shidler College of Business. We have already had a joint class, and soon the college's students will help with a community needs assessment, which will help the CCDC tailor its programs (classes, internships, and mentoring)

so that they are most effective in helping small businesses, particularly in Chinatown. Many of these programs will be a benefit for our own members, regular as well as associates. As the CCDC program evolves and develops, we will bring in other university entities, such as the Center for Chinese Studies and the Confucius Institute. We will also involve Hawaii Pacific University and Chaminade University as well.

On the foreign front, I want to inform you about our Chamber's Center for Foreign Relations. This Center was created to build on the excellent relations the Chamber has established with China-based organizations ever since our first annual Goodwill Tour to China in 1981. The Goodwill Tours were started not long after relations with the U.S. and China were normalized in 1979 and are a tribute to the efforts of our past presidents. The goal of the Center is to increase exchanges in the areas of business, culture, education, and science by using the synergy of our past activities with those of our current ones. Recent activities under the Center include military exchanges led by past president **Wesley Fong** and fundraising activities for Sichuan earthquake relief led by past president **Reuben Wong**. The Center works with all foreign countries, but concentrates in the Asia-Pacific region.

During the Goodwill Tour last year, the Chinese Chamber proposed and the Chinese government has accepted a project for the exchange of earthquake scientists. In early October, 25 earthquake scientists from the U.S will go to Beijing to attend the "China-USA Symposium for the Advancement of Earthquake Sciences and Hazard Mitigation Practices." The Chinese Chamber's Center for Foreign Relations is the

lead organization among those that include the U.S. Embassy, the Federal Emergency Management Agency, the U.S. Geological Survey, the University of Hawaii, the East-West Center, the Earthquake Engineering Research Institute, and many others. Chamber Executive Vice President **Wen Chung Lin** helped with these arrangements through our contacts with the China Association for International Friendly Contacts. In mid-April, I will attend meetings in Beijing on behalf of the Chinese Chamber, as part of the four-man U.S. coordinating team.

So members of the Chinese Chamber, if you have your own particular interest or project in China, and are willing to take the lead to run it through, contact the Chinese Chamber's Center for Foreign Relations and we may just be able to help. Also, please consider joining the 2010 Goodwill Tour, led by President-Elect **Jeff Lau**, as there will be many opportunities for business and cultural contacts.

Finally, I want to mention that all this year we have had many serious business and governmental meetings with the goal of advancing the Chamber and CCDC. However, I want all our members to reserve one event that is geared for FUN. Mark your calendars for on Monday, April 19, there will be a *pau hana* event open to Chamber members at Indigo restaurant, starting at 6:00 p.m. We should thank our Narcissus Queen and Court (**Angie Zhang, Selena Qiu, Megan Chun, Karen Chang, and Bonnie Von**), who are organizing the event. The ladies are using this event as a fundraiser for the Goodwill Tour and will be inviting Chamber members as well as their own family and friends. I hope to see you at Indigo for the good food and camaraderie.

## TAX CLASS

On Saturday, March 27, about 35 Chamber members and guests attended a morning tax seminar, "Taxes, Taxes, Taxes: What you and your business should know." The seminar was jointly sponsored by the Chamber's Chinatown Community Development Center and the Hawaii Mainland Chinese Overseas Association. Chamber members **Tina Au** and **Thomas Yamachika** spoke on "Individual and Small Business Tax Structure" and "Introduction to the Hawaii General Excise Tax." **Jonathan Hall**, risk manager at ProService then spoke on "What the Unemployment Insurance Tax Relief Bill (H.B. 2169) means to you," and the presentations were concluded by **Thomas Pearson**, an accounting professor at UH Manoa, discussing "Strategies for Avoiding an IRS Audit." All in all, it was quite informative and well worth attending. The seminar was organized by Chamber Second Vice President **Libby Lew**, who deserves thanks for all her hard work.
